As per this office order read 1st, 10 senior most Senior Co-Operative Inspectors, who were included between rank no 45 to 84 in the final seniority list of Senior Co-operative Inspectors for the period from 01/01/2007 to 31/12/2011 published vide order read 2nd, were granted percentage based special grade in the scale of pay of 16980-31360 according to the date of occurrence of vacancies. On verification of this office records, it is noted that Shri. R.Sukesh, SCI, Special grade was promoted as Assistant District Industries Officer vide order read 3rd with effect from 05/11/2014. The said vacancy has not been reckoned in sanctioning percentage based special grade vide order read 1st. Further, the seniority position of Shri. V.Vasanthasenan & Shri. Abhilash Vijayan, in the seniority list read 2nd, were re-assigned as rank no 56A & 67A respectively vide orders read 4th & 5th. Accordingly, they are eligible for percentage based special grade among the vacancies reckoned for sanctioning special grade vide order read 1st. Therefore, this office order read 1st needs modification reckoning the vacancy arised consequent on promotion of Shri. R.Sukesh, SCI and also considering the two incumbents mentioned above upon re-assignment of their seniority position, Hence the order.

ORDER

In the circumstances stated above, sanctioned of percentage based special grade as per order read 2nd, is modified as detailed in the list appended. The details of modification made is noted in the remarks coloumn of the appendix. The incumbents whose date of effect of sanction of special grade has been re-assigned consequent on above modification and also those incumbents who are newly included in sanction of special grade will be eligible fixation of pay in accordance with the provisions laid down in Rule 28 A Part I KSR. Consequent on the modification made, the sanction of Special Grade to Shri. K. Manoharan, SCI vide order read 2nd stands cancelled.
